ORDINANCE OF THE TOWNSHIP OF JACKSON, COUNTY OF OCEAN, STATE OF NEW JERSEY, AMENDING CHAPTER 204, ARTICLE I OF THE TOWNSHIP CODE OF THE TOWNSHIP OF JACKSON, ENTITLED "FIRE PREVENTION", SECTION 204-3 ENTITLED "AGENCY DESIGNATION AND ORGANIZATION" AND SECTION 204-4 ENTITLED "FIRE OFFICIAL; FIRE INSPECTORS AND OTHER EMPLOYEES"

BE IT ORDAINED, by the Mayor and Township Council of the Township of Jackson, County of Ocean, State of New Jersey, as follows:

SECTION 1. The Township Code of the Township of Jackson is hereby amended and supplemented, so as to amend Chapter 204, entitled, "Fire Prevention," Article I entitled "Administration and Enforcement" as follows:

SECTION 2. Chapter 204, Section 3, entitled "Agency designation and organization", Subsections (B) and (C) are hereby deleted and replaced with the following:

§204-3. Agency designation and organization

- B. The LEA located within the geographic boundaries established by ordinance for Fire District Nos. 1 and 2 shall be the Board of Fire Commissioners of Fire District No. 2, who shall operate the Bureau of Fire Safety Fire District Nos. 1 and 2, which is hereby created to enforce the NJUFC within the respective geographic boundaries of those districts. The Fire Official for First District Nos. 1 and 2 shall report to the Board of Fire Commissioners of Fire District No. 2.
- C. The LEA located within the geographic boundaries established by ordinance for Fire District No. 3 shall be the Board of Fire Commissioners of Fire District No. 3, who shall operate the Bureau of Fire Safety Fire District No. 3, which is hereby created to enforce the NJUFC within the respective geographic boundaries of those districts. The Fire Official for First District No. 3 shall report to the Board of Fire Commissioners of Fire District No. 3.
- D. The LEA located within the geographic boundaries established by ordinance for Fire District No. 4 shall be the Board of Fire Commissioners of Fire District No. 4, who shall operate the Bureau of Fire Prevention Fire District No. 4, which is hereby created to enforce the NJUFC within the respective geographic boundaries of those districts. The Fire Official for First District No. 4 shall report to the Board of Fire Commissioners of Fire District No. 4.

SECTION 3. The Township Code of the Township of Jackson is hereby amended and supplemented so as to amend Chapter 204, entitled, "Fire Prevention," Section 4, entitled "Fire Official; fire inspectors and other employees" as follows:

SECTION 4. Chapter 204, Section 4, entitled "Fire Official, fire inspectors and other employees", Subsection (A) entitled Fire Official appointments", Sections 1 and 2 are hereby deleted and replaced with the following:

§204-4. Fire Official; fire inspectors and other employees

- (1) The LEA for Fire District Nos. 1 and 2 shall be under the direct supervision of a Fire Official appointed by the Board of Fire Commissioners of Fire District No. 2, pursuant to and in accordance with the New Jersey Civil Service Rules and Regulations, Title 11 of the Revised Statutes.
- (2) The LEA for Fire District No. 3 shall be under the direct supervision of a Fire Official appointed by the Board of Fire Commissioners of Fire District No. 3, pursuant to and in accordance with the New Jersey Civil Service Rules and Regulations, Title 11 of the Revised Statutes.

SECTION 5. All ordinances or parts of ordinances inconsistent herewith are hereby repealed.

SECTION 6. If any section, subsection, sentence, clause, phrase, or portion of this ordinance is for any reason held to be invalid or unconstitutional by a court of competent jurisdiction, such portion shall be deemed a separate, distinct, and independent provision, and such holding shall not affect the validity of the remaining portions hereof.

<u>SECTION 7</u>. After second reading and publication (as required by law), this ordinance shall take effect **July 1, 2015**.
