Resolution

Establishing the Compensation for Members of the Board of Fire Commissioners

WHEREAS, *N.J.S.A. 40A:14-88* provides that each member of the Board of Fire Commissioners shall receive as compensation such amounts as the Board shall fix; and

WHEREAS, *N.J.S.A. 40A:14-88* further provides that the compensation so fixed shall be subject to review by the governing body wherein the Fire District is located; and

WHEREAS, the compensation for members of the Board shall be \$5,000 annually per Commissioner and \$6,000 annually for the Supervisory Commissioner.


NOW, THEREFORE, be it RESOLVED by the Commissioners of Fire District No. 3 in the Township of Jackson, County of Ocean, as follows:

(1) The Commissioners shall receive the compensation set forth above subject to review by the governing body of the municipality.

(2) A copy of this resolution shall be forwarded to the governing body of the municipality upon adoption.

**APPROVING COMPENSATION FOR THE COMMISSIONERS OF FIRE
DISTRICT NO. 3 PURSUANT TO THE OCTOBER 13, 2025 RESOLUTION OF
THE BOARD OF FIRE COMMISSIONERS**

WHEREAS, the Township of Jackson contains Fire District No. 3, which is governed by an elected Board of Fire Commissioners pursuant to N.J.S.A. 40A:14-70 et seq.; and

WHEREAS, on October 13, 2025, the Board of Fire Commissioners of Fire District No. 3 adopted a resolution establishing annual compensation for its members; and

WHEREAS, that resolution set the annual compensation for each member of the Board of Fire Commissioners at \$5,000, and further set the annual compensation for the Supervisory Commissioner at \$6,000; and

WHEREAS, pursuant to applicable law, the governing body of the municipality must approve the compensation of members of the Board of Fire Commissioners; and

WHEREAS, the Township Council of the Township of Jackson has reviewed the compensation set by the Board of Fire Commissioners and finds it reasonable and appropriate.

NOW, THEREFORE, BE IT RESOLVED by the Township Council of the Township of Jackson, County of Ocean, State of New Jersey, that:

1. The Township approves the compensation for the members of the Board of Fire Commissioners of Fire District No. 3 as established by the October 13, 2025 resolution of the Commissioners.
2. This approval shall remain in effect unless and until modified by subsequent action of the Board of Fire Commissioners and approval of the Township Council pursuant to law.

BE IT FURTHER RESOLVED that a certified copy of this Resolution shall be provided to the Board of Fire Commissioners of Fire District No. 3 for its records.
